## Bioxyne among leading ASX % Gainers on high volume

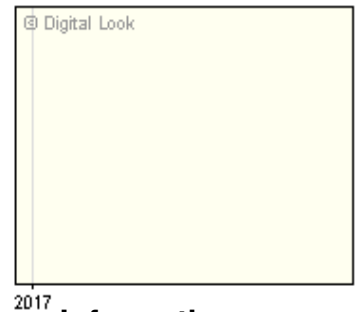
Bioxyne Ltd (ASX:BXN) shares have jumped 53% to \$0.072 intra-day with 11 million changing hands.
