## Titomic signs MOU to distribute TFK systems in Japan and South Korea

Titomic Ltd (ASX:TTT) has executed an MOU with Japanese companies Osaka Titanium Technologies Co Ltd (OTC) (TYO:5726) and Marubeni Corp (TYO:8002) to distribute Titomic Kinetic Fusion (TFK) systems in Japan and South Korea.

The MOU also involves the supply of aerospace-grade gas-atomised titanium metal powders from OTC globally.

Titomic has tested OTC's aerospace-grade titanium powder as being suitable for use in TFK systems and the MOU has several strategic advantages to further improve Titomic's position and progress.
