Importantly it is now enforceable against any potential infringer.

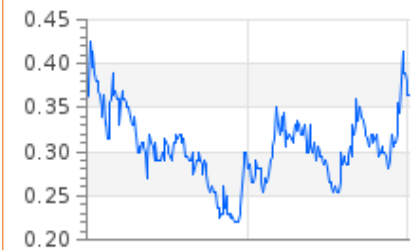
Hazer's chief executive officer Geoff Ward said: "We are very pleased to receive the certification of this innovation patent and the continued progress of our intellectual property strategy.
