Wellness and Beauty Solutions launches nailKALM anti-fungal product in Chemist Warehouse

Biovite managing director Danny Goldman said the research company and GBCo had worked closely to ensure nailKALM was distributed into the Australian marketplace, which contains about 1.7 million nail fungal sufferers.

Goldman said: "Having the product available in Chemist Warehouse, Australia's leading pharmacy group, will go a long way in achieving this goal."
