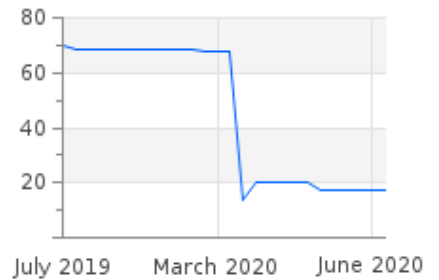
"They've rebounded and on the whole it's been going very well", Turtelboom says.
