Andromeda Metals (ASX:ADN) managing director James Marsh speaks to Proactive Investors about the company's strategic shift of focus to industrial metals; namely halloysite kaolin and HPA. "Our plan is to push through the PFS as quickly as possible to get into development, start a direct shipping ore business going, and then the process material," Marsh says. He continues, "in the meantime we are working on the HPA angle because we know we've got a very good feed material for that." Along with a variety of HPA end-uses, Andromeda's halloysite kaolin can be used in a range of industrial applications including as a catalyst for breaking down petrochemicals and to produce carbon nano-structures for the battery industry.
