MyFiziq's (ASX:MYQ) body scanning app hold enormous potential for fitness tracking, online clothing retailers and insurance companies.

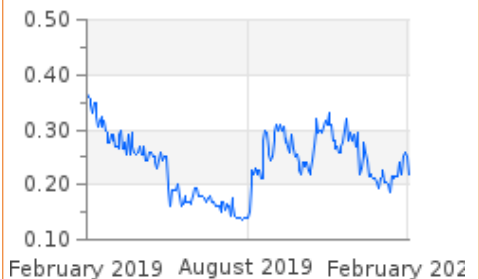
