CEO of Medallion Resources sees trade dispute between China and US as an opportunity

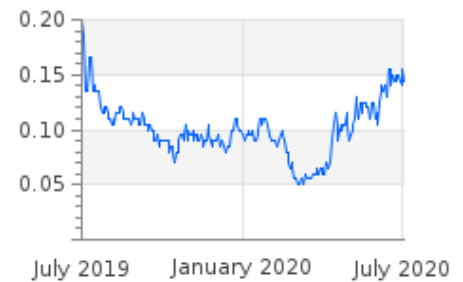
