## Animoca Brands closes \$3.6-million capital raising to fund tokenised blockchain gaming platform

Animoca Brands Corporation Ltd (ASX:AB1) co-founder and chairman Yat Siu updates Proactive Investors on the mobile gaming and tech company's \$3.6-million capital raising to develop a blockchain version of its mobile game franchise The Sandbox.

The blockchain version of the gaming platform will be an early-mover in decentralised, community-driven game platforms, providing users with true ownership of their creations as non-fungible tokens.

"With a blockchain version of a game, you would actually own the items permanently - this is the whole thing about non-fungible tokens," says Siu.

He continues, "It's also user-generated - it allows anyone to make their own NFTs which I think is new and a revolutionary concept in the world of gaming."
