Full interview: Thor Mining reports back on further good tungsten and copper grades at Molyhil

Thor Mining PLC's (LON:THR)(ASX:THR) Mick Billing caught up with Proactive London's Andrew Scott following the release of further assay results from the second metallurgical bulk sample drill hole at the company's wholly-owned Molyhil tungsten molybdenum deposit.

Among the highlights were 3.5 metres grading 1.32% tungsten trioxide (WO₃), 10 metres at 0.32% copper, and 10 metres at 1.32% WO₃.

The drilling also intersected molybdenum.
