"I think that's quite an ambitious target to be setting at this point ... the next breakout number \$1525/oz and thereafter the chartists will look for something like \$1560/oz".

"If you're a gold bull then \$2000/oz will be the supremely optimistic case but if gold hits those levels then it probably means a lot has gone wrong in the global economy and a lot of other investment asset classes have tanked".
