Full interview: Scancell back in the clinic with a phase II trial of its flagship skin cancer treatment

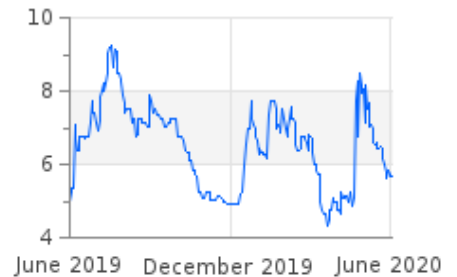
