## Full interview: Orion Minerals granted mining right for flagship South African copper-zinc project

Orion Minerals Limited (ASX:ORN) managing director and CEO Errol Smart updates Proactive Investors on the company being granted the key mining right by the South African Department of Minerals Resources and Energy for the Prieska Copper-Zinc Project in South Africa.

This marks a major milestone in development of the flagship project and clears the way for development to commence, subject to a Final Investment Decision.

Smart also spoke of the signing of an MOU with Byrnegut for mining contract work as a strategic move for the project moving forward.
