This was part of a delegation arranged by Federal Resources Minister Matt Canavan's to meet US government officials in order to address the rare earths crisis.


It followed meetings between US President Donald Trump and the Australian Government a few months back to discuss China's control of around 80% of global trade in rare earths and critical minerals.
