Full interview: Brookside Energy expands oil & gas acreage position in prolific Anadarko Basin

Brookside Energy Limited (ASX:BRK) managing director David Prentice speaks to Proactive about the recent acreage expansion in the Anadarko Basin of Oklahoma, USA.

Two additional SWISH Area of Interest (AOI) Drilling Spacing Units (DSUs), Rangers and Flames, have been secured in the world-class region.

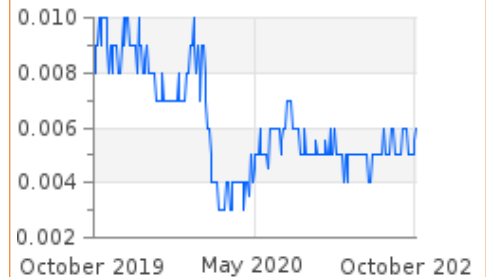
The company's ongoing successful leasing, trading and high-grading activities have now delivered three DSUs - Jewell, Rangers and Flames - in the core of the SWISH AOI.

Prentice said the three DSUs combined were more than six-times the size of the acreage position the company secured in the pilot study in the STACK Play.
