MGC Pharmaceuticals Ltd (ASX:MXC) co-founder and managing director Roby Zomer will also present at the event, along with Zelira Therapeutics (ASX:ZLD) managing director and CEO Richard Hopkins.

The companies will discuss on the global medical cannabis, which is predicted to grow at a compound annual growth rate (CAGR) of 15.4% from 2019 to 2025, and is expected to be worth US\$52.35 billion by 2025, according to Market Research Future (MRFR).
