Comet Resources' Matthew O'Kane talks plans for Santa Teresa gold project following acquisition

Comet Resources Limited's (ASX:CRL) Matthew O'Kane caught up with Proactive's Andrew Scott after completing the acquisition of a 50% stake in the Santa Teresa Gold Project. Historical production in the surrounding El Alamo district is estimated at between 100,000 to 200,000 ounces and Comet intends beginning work on re-assaying historic drill core and preparing a JORC-compliant resource estimate.
